# Annual Report 2024-2025



## A message from the Chair and CEO



Young people, the youth sector and YN0T continued to create positive change in Tasmania throughout 2024-25.

During the year, young people experienced a marked increase in demand for their contributions to the processes that shape our government systems. This is testament to many years of work by YNOT and our sector to embed the views and experiences of young people in policies and processes that affect them. YNOT continued to support young people to participate in these activities through capacity building and coordination of formal and informal consultation mechanisms.

YNOT also identified an urgent need to support organisations and individuals in the delivery of safe, ethical and meaningful youth consultation following the introduction of the Child and Youth Safe Organisations Framework and Standards. In response, and to build capacity and understanding across our community, we developed an evidence-informed, cross-sector professional learning program and toolkit focused on youth participation.

In 2024-25, YNOT maintained its outsized impact on policy, participation and the sector while also undertaking major organisational changes to ensure we remain focused, responsive and inclusive. These changes included a refreshed volunteer board, an external review of operations, a modernised constitution and a soon-to-be-launched 2025-2028 strategic plan.

The continued inadequacy and uncertainty of funding for the youth sector made the past 12 months particularly demanding for YNOT and its members. We continue to work with TasCOSS and our fellow peak bodies to achieve fair indexation and greater funding certainty to provide a stronger foundation from which our members can plan and deliver services.

Thank you to all who have contributed to the many successes experienced this year including the YNOT team, Jo Horton, Michelle Sims and Rachael Stanic, YNOT members, our volunteer board members and Youth Advisory Council, and our many partners.

We especially thank Tasmania's young people for their continued contributions to creating positive change. Your enthusiasm, generosity and optimism sit at the heart of all we do.

# An adaptive, skilled and effective youth sector

YNOT continued its member support and advocacy throughout 2024-25 with highlights including a sold out, one-day Sector Symposium, focused advocacy for sustainable funding/indexation, and ongoing analysis of issues and decisions affecting our sector.

#### **YNOT** activities

- Delivered the 2025 Youth Sector
  Symposium which brought more than
  140 sector, state and local government
  representatives together for a meaningful
  day of learning and connection.
- Delivered a pilot Professional Learning Program on Youth Participation to enhance workforce capability.
- Built and strengthened relationships with key stakeholders including Neighbourhood Houses Tasmania, Local Government Association of Tasmania and the Office of the Independent Regulator.
- Produced the evidence-informed Youth Participation Toolkit in collaboration with young people, the Youth Affairs Council of South Australia and the Youth Affairs Council of Western Australia.

#### In 2025-26, YNOT will

- Continue working collaboratively with the youth sector to strengthen its legitimacy, visibility and recognised value.
- Foster partnership opportunities to amplify young people's views and embed them in planning, systems design and decision making.
- Continue our partnership with the Department of Education, Children and Young People (DECYP) to develop a Child and Youth Participation Guide that offers best practice guidance on engaging children and young people in decision-making across Education, Libraries, Child Safety, and Youth Justice services in Tasmania.

### Young people influence issues relevant to their lives

This year, government policies and systems benefited from young people's generous insights and contributions on topics ranging from election priorities to formal submissions and face-to-face advocacy of decision makers.

#### YNOT activities

- Supported YNOT's Youth Advisory Council (YAC) to develop its powerful Federal Election Youth Priorities Statement and communicate their priorities to candidates.
- Produced formal submissions in response to government, including the Change for Children Strategy, the Independent Review of Education in Tasmania and the State Budget Community Consultation.
- Supported young people to advocate for stronger action on key issues including cost-of-living relief, mental health, housing security, climate action and education.
- Delivered youth consultation in partnership with Create Foundation and the Commissioner for Children and Young
  People to help shape the new Commission for Children and Young People in Tasmania.

### In 2025-26, YNOT will

- Strengthen youth led advocacy and participation opportunities by empowering young people to share their views, contribute to decision making and actively shape public policy, programs and initiatives that affect their lives.

## Young people have a voice on issues that matter to them

#### YNOT activities

- Established a new youth advisory group to inform YNOT's operation and policy positions.
- Relaunched the Tasmanian Youth Voice Network (TYVN) in partnership with Brand Tasmania.
- Supported young people to lead advocacy and amplify their views in broadcast, print and social media.

Strengthen communication between young people and decision makers by:

- providing support and capacity building opportunities.
- delivering regional youth forums.
- promoting inclusivity, diversity and increased youth participation.
