1. Youth Week Tasmania

Youth Week Tasmania, supported by the Tasmanian Government, celebrates the contributions, creativity and leadership of young people across the state.

In 2026, \$30,000 is available through the Youth Week Tasmania Small Grants Program, offering grants of up to \$2,000 for eligible organisations to deliver Youth Week events, activities or projects.

Youth Week Tasmania 2026 will run from Thursday 16 April to Thursday 23 April 2026.

This years' theme, chosen by young people, is 'Our Voice. Our Vision. Our Future'.

The theme celebrates the power and potential of all young people. It recognises that young people's ideas and perspectives matter (**Our Voice**), encourages them to imagine and shape possibilities for themselves and their communities (**Our Vision**), and highlights their role in creating positive change for tomorrow (**Our Future**). The theme inspires young people to lead, participate, and have a real impact on the world around them.

Coordinated by the Youth Network of Tasmania (YNOT), the Small Grants Program empowers communities to deliver meaningful, youth-led initiatives.

The program aims to:

- Showcase the talents and achievements of young Tasmanians
- Celebrate the positive contributions young people make in their communities
- Build capability by involving young people in planning and delivering Youth Week activities.

Youth Week Tasmania is a statewide, inclusive celebration that embraces young people from all backgrounds and encourages participation across every region.

2. Eligibility Criteria

Eligible Applicants

Applications are welcome from organisations that work with or support young people in Tasmania including;

- Local government authorities (councils)
- Not-for-profit incorporated community organisations
- Other not-for-profit organisations or community groups, including parents and friends' associations
- Government and non-government schools, colleges and tertiary institutions.

Eligibility Requirements

To be eligible applicants must:

 Be an organisation that provides services, programs or support to young people in Tasmania





- Deliver the activity in Tasmania and ensure alignment with Youth Week Tasmania theme
- Demonstrate meaningful involvement of young people in event planning and/or delivery
- Comply with the Child and Youth Safe Organisations Framework and the Registration to Work with Vulnerable People Act 2013
- Develop and implement an event-specific risk management plan that includes appropriate child and youth safety measures, supervision arrangements and duty-ofcare requirements
- Hold an ABN, or be auspiced by an organisation with an ABN
- Hold appropriate public liability insurance and provide documentation.

Ineligible Applicants

The following entitles are not eligible to apply:

- Australian Government agencies;
- Tasmanian Government agencies (except schools)
- Political parties
- For profit organisations.

Applicants may be required to provide documentation to verify eligibility. Applicants uncertain about their eligibility are encouraged to contact YNOT.

Eligible Events and Activities

To receive funding eligible applicants must also ensure that:

- Events/activities will be delivered between 16-23 April 2026
- All Youth Week events must be drug and alcohol free
- Events must be free or low cost for young people
- Events must have a risk management plan in place addressing child and youth safety, supervision and overall event safety.

Requirements for Successful Applicants

Successful applicants will be required to:

- Comply with all terms and conditions outlined in the Grant Agreement
- Spend funds as outlined in their application (any changes require prior written approval from YNOT)
- Use the Youth Week Tasmania, Youth Network of Tasmania, and "Supported by the Tasmanian Government" logos on all promotional material, outlined in the YWT event pack supplied prior to Youth Week
- Ensure the event is registered and included on YNOT's Youth Week Tasmania calendar of events
- Deliver the event in accordance with the YWT event pack
- Implement and maintain a risk management plan and ensure appropriate child-safe practices are in place throughout planning and delivery
- Submit a final grant acquittal and final report at the completion of the grant to demonstrate that the funding was used for the approved purpose





 Return grant funds to YNOT if any information provided is found to be false or misleading, or if the applicant fails to comply with the grant requirements.

Activities **NOT** eligible for Funding

Funding will not be provided for:

- Staff wages, unless it involves additional hours specifically for the Youth Week Tasmania project.
- Equipment, building, refurbishment and maintenance (although supplies/consumables for project delivery are acceptable)
- Projects that require ongoing funding
- Ongoing commercial activities
- Initiatives already funded through other grants or existing commitments, including requests for additional funding to extend or enhance work that is already funded.

3. Selection Criteria

Applications for the Youth week Tasmania Small Grants program are assessed by the Youth Week Tasmania Selection Panel. As the program is highly competitive, all applications will be assessed on how well they meet the following criteria.

1. Eligibility Compliance

Demonstrates full compliance with all eligibility requirements and alignment with the 2026 Youth Week Tasmania theme.

2. Supports Youth Week Tasmania Objectives

Opportunities for young people to display their skills and talents and contributions to the community

3. Community Involvement

Provides meaningful opportunities for young people to be involved in event planning, decision-making and delivery.

4. Benefit to Young People

Demonstrates benefits to young people, contributes to the success of Youth Week Tasmania and is inclusive of all young people.

5. Value for Money

Shows willingness to engage in meaningful partnerships with other organisations or agencies.

6. Defined Event Targets

Sets clear and realistic targets for audience size, participation and event reach.

7. Promotion Strategy

Outlines well-planned and effective promotional activities for engaging the intended audience.

8. Financial Planning

Demonstrates a realistic, well-prepared budget with clear justification of expenditure.





4. Assessment Process

- Applications are assessed solely on information provided in the application form.
- Late applications will not be accepted.
- YNOT may request additional information; applicants must respond within 3 working days unless otherwise advised. Failure to do so may result in the application being unsuccessful.
- Successful applicants will receive a Grant Agreement outlining funding terms and conditions.
- Applications may be refined and resubmitted in future grant selection rounds.

5. Key Dates

6. How to Apply

Applicants must complete the online application form available on the Youth Network of Tasmania website: https://www.ynot.org.au/young-people/youth-week-tasmania

When an application is submitted through the online application form, an automatic confirmation message is generated. It is recommended that applicants save a copy of this message and their application for their records. A confirmation email will be issued by YNOT within five business days.

7. Notification of Grant Outcome

Successful and unsuccessful applicants will be notified of the outcome in writing.

Unsuccessful applicants can request feedback on their application by contacting YNOT.





8. Successful Applicants

Taxation and financial implications

Organisations must indicate whether they are registered for GST in their application. Successful applicants will be advised if GST applies and will be required to issue an invoice to YNOT for grant payment.

It is strongly recommended that applicants contact the Australian Taxation Office (ATO) on 13 28 66 or www.ato.gov.au for any advice or clarification on GST.

Reporting and Evaluation

Organisations that receive funding through the Small Grants Program are required to complete a Final Report using a template that will be provided by YNOT.

Completion of a feedback form by grant recipients is part of this process.

The Final Report must include a financial acquittal and may require a Statement of Compliance confirming funds were spent appropriately. As part of reporting, organisations will be asked to evaluate their event with young people, including those involved in delivery and as participants. Information from all reports will contribute to program evaluation by YNOT and the Tasmanian Government.

9. Appealing a Decision

Applicants may request a review if they believe assessment processes were not followed fairly or appropriately. Requests must be in writing within 28 days of notification. Grounds for appeal include:

- 1. A conflict of interest, bias, or unfair treatment affecting assessment.
- 2. Incorrect advice provided by YNOT during the application preparation.
- 3. Discrimination on irrelevant grounds such as cultural, religious or linguistic background; race; gender; marital status; sexual orientation; or disability.
- 4. Procedural or assessment errors, including incorrect application of eligibility criteria, deadlines or failure to consider relevant information submitted by the applicant.

10. Privacy and Information Management

Personal information

Personal information will be managed in accordance with the *Personal Information Protection Act 2004*.

Right to information

Applicants may request a copy of their own grant application and related documents from YNOT. Documents will not be provided to external parties.
